BACKSTORY In 2018, AECl conducted an evaluation of their EAM system and concluded that their existing software:

- Was heavily customized and outdated which resulted in poor usability
- Created workflow disruptions during upgrades
- Failed to provide convenient access to critical data
- Wasn't scalable to align with their growth and asset maturation initiatives


This exercise revealed that it was the right time to invest in a new EAM system and determine their wider asset management goals.

People



Collaborative team: Stratum equipped AECl for their transition by conducting demos, explaining the basic principles of the new EAM system, and building confidence so AECl staff could lead as project SMEs.
